

## Required General Liability Insurance

Per rule number 13\* of the Exchange 2024 Contract for Exhibit Space, each exhibiting company is required to show evidence of commercial general liability insurance coverage by providing GEAPS a certificate of insurance. Not providing a Certificate of Insurance will exclude the exhibiting company from participating in GEAPS Exchange 2024.

Please double-check that all certificates meet the following requirements:

- Certificates must cover “Commercial General Liability” insurance.
- The certificate must cover the dates of **February 22-28, 2024**.
- The limit for each occurrence must be set at a minimum of \$1,000,000.
- Both GEAPS and Kansas City, Missouri need to be included on the certificate as additional insureds. The language would look like this, “Grain Elevator and Processing Society (GEAPS) and the city of Kansas City, Missouri are additional insureds with respect to the insured’s exhibit at the GEAPS Exchange.”

### **\*13. Assumption of Risks: General Liability Insurance**

Each Exhibitor MUST provide a Certificate of Insurance evidencing Commercial General Liability insurance. Certificates must be sent to, and received by Grain Elevator and Processing Society (GEAPS) by December 1, 2024. Not providing a Certificate of Insurance will exclude the exhibiting company from participating in GEAPS Exchange 2024. Please note that Commercial General Liability Certificates of Insurance must show the following: Single Limit of liability in the amount of \$1,000,000 per occurrence. The Additional Insureds should be listed as Grain Elevator and Processing Society (GEAPS) and the city of Kansas City, Missouri. Exhibitor assumes risk associated with, resulting from or arising in connection with Exhibitor’s participation or presence at the Exhibition, including, risks of theft, loss, harm or injury to the person (including death), property, business or profits of Exhibitor, whether caused by negligence, intentional act, accident, Act of God or otherwise. Exhibitor has sole responsibility for its property or any theft, damage or other loss to such property (whether or not stored in any courtesy storage areas), including any subrogation claims by its insurer. The exhibitor agrees to carry appropriate insurance to cover these risks. Neither Grain Elevator and Processing Society (GEAPS) nor the Exhibit Facility accepts responsibility, nor is a bailment created, for property delivered by or to the Exhibitor. Neither Grain Elevator and Processing Society (GEAPS) nor the Exhibit Facility, nor any of their respective officers, directors, shareholders, employees, representatives or assigns, shall be liable for, and Exhibitor hereby releases all of them from, and covenants not to sue any of them with respect to, risks, damages and liability described in this paragraph.
